# 1. PROFESSIONAL SERVICES AGREEMENT WITH SOUTHWEST INSPECTION AND TESTING

General Manager Martinez explained that this proposed Professional Services Agreement is time and material as needed with an amount not to exceed \$26,005.00. General Manager Martinez said it is the owner's responsibility to perform this testing and the recommendation is to approve this Agreement to ensure the project meets all required standards. There was no public comment. Board asked questions. Construction Manager, Sean Leonard, Leonard and Associates, gave a general overview of the testing, inspection, and requirements. Director Brewer made the motion to approve the Agreement. Director Nast seconded the motion.

General Manager Martinez commented that the neighbors have been cooperative and excited about the project's inception.

General Manager Martinez said the PHWA most likely not be meeting this month.

General Manager Martinez said that it is time for the General Manager review and the Board will be receiving an email with evaluation materials from Office Manager Dillon next week.
