## CONSTRUCTION NOTICE

for

### HOLLYWOOD BEACH WATERLINE IMPROVEMENT PROJECT (CI 101)

This capital improvement project involves the installation of 750 linear feet of Polyvinyl Chloride (PVC) pipe in the neighborhood bounded by Santa Ana Ave (north), 3000-3200 blocks of Ocean drive (west), and Harbor Blvd (east & south). Additionally, this project will also include the abandonment of a water pipeline located in the utility easement at the rear of the 3000, 3100, and 3200 addresses on Ocean Drive.

Please see below for more project information:

- Construction is expected to **start on January 23, 2023 and** will be completed by April 3, 2023.
- The contractor will send notices 48-hours prior to water shutdown or disruption.
- Some streets will have partial lane closures during construction. Residents in the vicinity of the construction areas are advised to observe all safety signs posted at the construction work zones.
- Contractor's work hours are between 7:00 a.m. and 5:00 p.m. Monday through Friday. If any changes to the work schedule are required, an advance notice will be given to the residents.

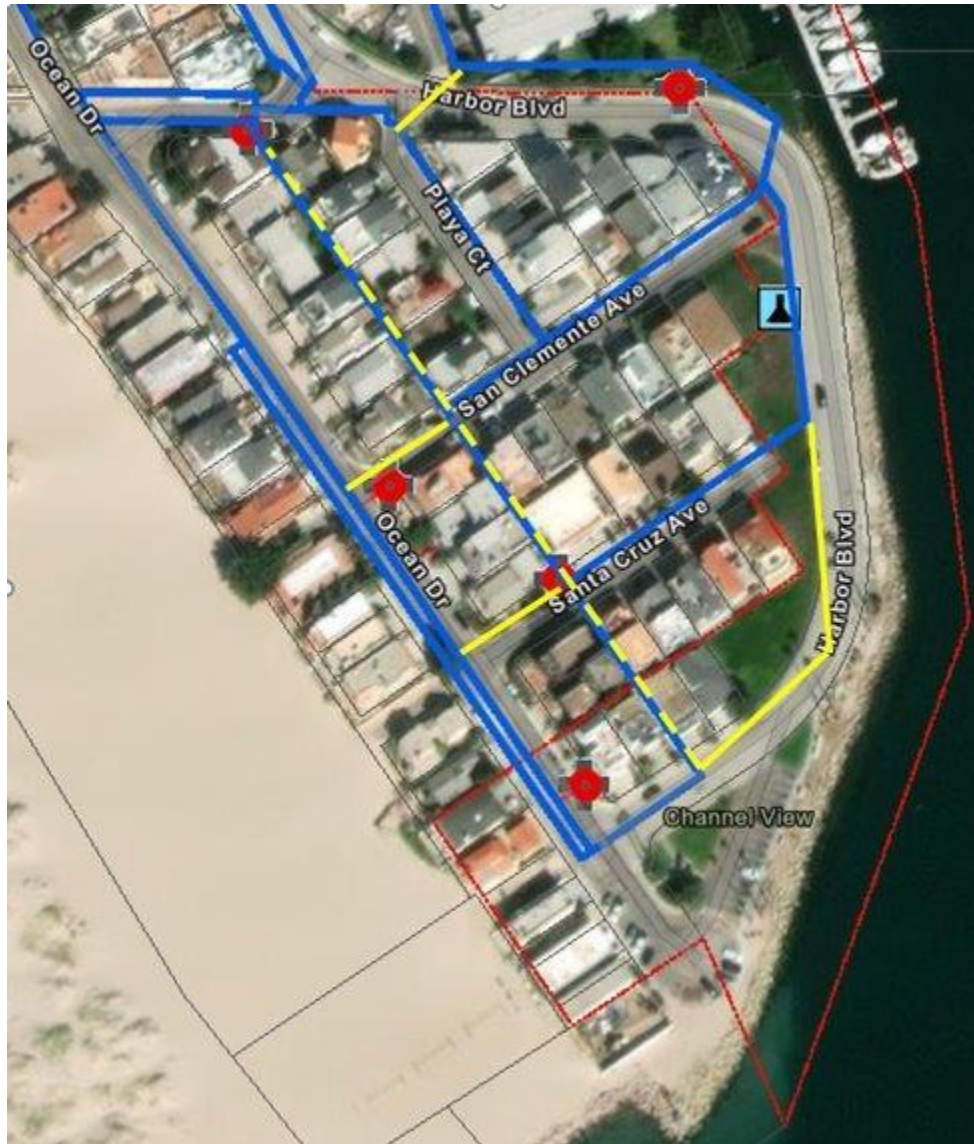
